
Chapter 2 What's New

Supports searching for animals. The feature should be supported by the device.


For animal search results, AcuSearch is not supported.




2.2 Person

2.2.1 Added Features


1. The person list now includes an option to show or hide the Gender column.



2. When exporting person information, supports selecting and exporting the Gender field and custom properties.




3. Supports exporting person information stored in access control devices.




2.3 Broadcast

2.3.1 Added Features


1. Adds the features device batch settings and channel batch settings.
 - Device batch settings: Manage audio input sources.
 - Input Volume Adjustment: Set volume levels individually for each source (e.g., Bluetooth, USB, FM).
 - Channel Input Settings: Assign specific audio sources to output channels.
 - Channel batch settings: Control audio output channels.
 - Adjust overall audio levels and fine-tune final output effects.



2. Adds the feature SIP batch settings.



3. Adds the feature FM Broadcast.



2.4 Account and Security

2.4.1 Added Feature

Security questions now have an attempt limit: if verification fails three times, the feature will be locked for 15 minutes. Users can try again after the lockout period.
